Being an Act to amend the *Appropriation (General Public Services Expenditure 2020) Act 2019* to include changes to the figures approved by the National Executive Council but not included in the *Appropriation (General Public Services Expenditure 2020) Act 2019*, and for related purposes,

MADE by the National Parliament.

**1. GRANT FOR GENERAL PUBLIC EXPENDITURE OF K30,268,376,509.00 (AMENDMENT OF SECTION 1).**

Section 1 of the Principal Act is amended by repealing -

- (a) the figure “K30, 268,376,509.00” twice appearing and replacing them with the figure “K30,268,312,509.00”; and
- (b) Paragraph (a) and replacing it with the following:

(i) Personal emoluments	K5,470,786,845.00; and
(ii) Goods and Services	K3,687,235,915.00; and
