Wednesday 2 August 2017

The National Parliament met at 11.13 a.m., pursuant to Notice of His Excellency the Governor-General, **Sir Bob Dadae**, which was published in the *National Gazette*.

The Clerk read the Notice.

The Clerk - I have to announce that I have received the return of writs for 106 electorates from the Governor-General and I will now read out the names of all electorates and Members against the list that I have received. Starting with Member for Bougainville Provincial, Mr Joe Lera, Member for Central Bougainville –

Mr Kerenga Kua – Point of Order! There is a domestic house-keeping issue that needs to be raised at this point before we move on. Insofar as all practical purposes are concerned, you are now in charge of administration of the Standing Orders in the absence of an elected Speaker.

The point of order is on the floor and it takes priority above everything else and that has to be determined now.

The point of order is this; we are now proceeding into the formalities of a supposedly constituted Parliament. And every individual on the Floor of this Parliament has to be duly elected. Right now, Mr Clerk, you have so many strangers on the Floor of this Parliament, especially on that side of the Parliament and I can tell you, Mr Clerk, that there are six strangers on the Floor of this Parliament as you speak.

Mr Clerk, you are duty bound under *Standing Order 242* to order the withdrawal of strangers on this Floor of Parliament before any other step is taken and even before the Chief Justices comes in and you read the names on the writs sent to you by the Governor-General. Now let me point out to you the strangers here so that you can move forward very quickly.

(Members interjecting)

Mr Kerenga Kua - Mr Clerk, listen to me, I have the Floor so ask those people to sit there quietly and they will learn something for once in their life.

(*Members interjecting*)

Mr Kerenga Kua - Mr Clerk, listen carefully, the first stranger on this Floor of Parliament is the purported Member for Ialibu-Pangia. He is a stranger and ought to be removed by an order of withdrawal.

Don't come here, go and take your chair, I got the Floor. Go and stand over there.

I also take this time to thank the former Members such as myself, who has been reelected to this Parliament to bring class to this Parliament.

You have to wait until tomorrow or later this afternoon when we will see whether changes will happen or you will continue. So let us not confuse Papua New Guinea.

We have already appointed the Speaker who has the power to appoint a time for us to appoint the Prime Minister so there might be changes, we may have a new government.

We all know the debates in the Parliament, the people of Papua New Guinea are watching and they are crying for change so you have to when we will elect our Prime Minister, whether it will be this afternoon or tomorrow, the Speaker will set a time for us to vote the Prime Minister.

Thank you to this Parliament and congratulations to the new government.

Dr ALAN MARAT (Rabaul) – Thank you, Speaker elect. I stand to congratulate you for mastering the confidence of the majority of Members of this Parliament.

I just wish to express a minor point of view that in the past we've had some slight struggles with the Chair and so let me remind the Honourable Speaker elect that we are looking

forward to the strict observance of the doctrine of the separation of powers between the Legislature, the National Executive and the Judicial arm of this Government.

Mr SPEAKER – Honourable Members of Parliament, I am humbled to accept this job as your Speaker for the Tenth Parliament. It is a mammoth task.

I am planning to be firm and bring back the integrity of this Parliament. TABLING OF THE COMMISSION TO ADMINISTER DECLARATION –

STATEMENT BY THE SPEAKER

Mr SPEAKER – Honourable Members, I have to report that I this day presented myself to his Excellency the Governor-General as the choice of the Parliament and that his Excellency was kind enough to congratulate me on my election as Speaker, where upon I made my declaration of office as Speaker.

His Excellency also presented to me a Commission authorising me to administer to new members the declaration of loyalty and the declaration of office. The Commission reads as follows:

The *Constitution* to the Speaker of the National Parliament greetings; whereas the *Constitution* of Papua New Guinea by section 249 provides amongst other things, that every Member of the National Parliament shall, before entering upon the duties or exercising any of the powers of his office make the Declaration of Office and the Declaration of Loyalty before a person appointed for the purposes by the Head of State in the form set out in Schedule 3 and Section 6 respectively of the *Constitution*.

Now therefore, I, Grand Chief, Sir Bob Dadae, Grand Chief of Logohu, Grand Cross of the Most Distinguished Order of Saint Michael and Saint George, Knight of the Order of Saint John, Governor-General, by virtue of the powers conferred by the Constitution, and all other powers me enabling, acting with, and in accordance with, the advice of the National Executive Council, hereby commission the Speaker of the National Parliament to administer the Declarations of those Members of the National Parliament who may have not already made the Declarations since their election to the National Parliament.

Dated this Thursday 18 of May, 2017.

I now lay the Commission on the table.

Mr SPEAKER – Honourable Members of the Tenth Parliament. It is with great pleasure and sincere gratitude. I humbly stand before you as the duly elected Speaker, of this honourable Parliament to make this brief statement.

In accordance with the requirement, the Governor-General has informed me that he has invited the People's National Congress Party to form the Government. His Excellency's invitation which was gazetted on *Friday*, 28 July, 2017 reads, and I quote:

'I Grand Chief, Sir Bob Dadae, Grand Chief of Logohu, Knight Grand Cross of the Most Distinguished Order of Saint Michael and St. George, Knight of the Order of St. John, Governor-General by virtue of the powers conferred by Section 63 of the Organic Law on the Integrity of the Political Parties and Candidates and all the other powers me enabling, acting in accordance with the advice of the Electoral Commission here invite the People's National Congress Party, being a registered political party which has endorsed and won the greatest number of candidates declared elected in the 2017 National Elections to form the Government.

Dated this 28 day of July, 2017

Signed: Bob Dadae, Governor General.

In accordance with this advice and the requirements of the Organic Law on the Integrity of Political Parties and Candidates and the provisions of the Standing Orders, I now call upon the People's National Congress Party to nominate a candidate for election of the Prime Minister.

Sir PUKA TEMU (Abau) – I, Puka Temu, Member for Abau and a member of the People's National Congress Party nominate Mr Peter O'Neill as the Parliament's choice for Prime Minister.

Mr WILLIAM DUMA (Hagen) – I, William Duma, Member for Hagen second the motion.

Mr SPEAKER -Honourable Peter O'Neill, do you accept the nomination?

Mr PETER O'NEILL (Ialibu-Pangia) – Mr Speaker, with great honour and humility I accept the nomination.

Mr JAMES MARAPE (Tari-Pori) - Mr Speaker, I move that nominations now be closed.

Mr SPEAKER – Honourable Members, the Parliament will now vote and those Members who support Honourable Peter O'Neill, move to my right and those Members who do not support the nomination move to my left.

Mr Speaker, we are proud to form the Government of the 10th Parliament of Papua New Guinea and now that we have formed the Government, we won't be discouraged by the views that are different to ours. We want to encourage debates that will continue to unite our nation. We will be a government that listens more, talks less, works harder at every opportunity. We will be a government that learns from its mistakes.

I would like to take this opportunity to also congratulate each Member who has been elected to this Parliament. And to all the Members of Parliament who are no longer with us; I commend your service to this nation. This year we have had a very vibrant election, while our elections are robust, the successful outcome is a demonstration of the strength of our democracy. There has been many challenges in this election but this has been one of the most peaceful elections in many parts of our country.

Mr Speaker, it has been an enormous undertaking for election officials, scrutineers, and members of our disciplinary forces and everyone who have been involved in the election process. There have been difficulties in the administrative and organisational level as well. And again as this government commits itself to a full independent review of the electoral process that will provide us with the opportunity for all stakeholders to share their views. Sir JULIUS CHAN (New Ireland) – Mr Speaker, I want to first of all congratulate the Prime Minister, Mr Peter O'Neill for being elected for the third time. And that's almost setting the record after the founder of this nation as the longest serving member of Parliament in the Commonwealth.

I am touched by the Prime Ministers statement. It's one of recognising some of the errors of the past and looking to the future.

Admitting it, we are all humans; people sometimes think that we are angles. Mr Speaker, we are not angles and we are not devil sider but we are somewhere in between. We make mistakes and we wait for the people to correct them.

The Integrity Laws on Political Parties is very clear and this Parliament passed it and Peter O'Neill was called to form the Government. The spirit of that law is that; he's got the highest majority expressed by the people and we got to respect the spirit of the law; that is why the Peoples Progress Party stood behind it right from the start.

So, I'd like to see more debates in the Parliament. Mr Speaker, if you can tolerate it so that the representatives of the people can exhaust themselves on the Floor of Parliament.

I think the size of the government is just right, as far as what we have now. It is quite a big majority. It is just right and we don't really need to dilute it any more.

Mr WILLIAM DUMA (Hagen) – Thank you, Mr Speaker. I'd like to take this opportunity on behalf of the people of Hagen and the United Resources Party which I lead to congratulate the Prime Minister who is also the Member for Ialibu-Pangia and Parliamentary Leader of the People's National Congress Party for being elected again as Prime Minister of this country.
