1. The Parliament met at two o'clock p.m., according to the terms of the resolution of 16 May 2014.  
*Absence of quorum:* The Speaker reported to the Parliament that a quorum of Members was not present and announced that he would resume the Chair at the ringing of the Bells.  
*Suspension of sitting:* At two o'clock p.m., the Speaker left the Chair.  
*Resumption of sitting:* At twenty minutes past two o'clock p.m., the Speaker resumed the Chair and a quorum of Members being present, and in accordance with Standing Order 34, invited Mr De Kewanu (Member for Mendi) to say Prayers.
