MINUTES OF PROCEEDINGS

NATIONAL PARLIAMENT

Tuesday, 25 November 2014

The Parliament met at ten o'clock a.m. pursuant to adjournment. The Speaker (Mr Theo Zurenuoc) took the Chair.

Absence of quorum: The Speaker reported to the Parliament that a quorum of Members was not present and announced that he would again take the Chair at the ringing of the Bells.

Suspension of sitting: At ten o'clock a.m., the Speaker left the Chair.

Resumption of sitting: At five minutes to eleven o'clock a.m., the Speaker resumed the Chair, and a quorum of Members being present and in accordance with Standing Order 34, invited Sir Puka Temu (Minister for Public Service) to say Prayers.

- BROADCASTING OF PARLIAMENTARY PROCEEDINGS STATEMENT BY THE SPEAKER: The Speaker informed the Parliament that the Permanent Parliamentary Committee on Broadcasting of Parliamentary Proceedings met this day and resolved that EMTV would be allowed to film the Budget Reply by the Opposition's spokesman this day at two o'clock p.m. for news purposes only.

4 **DEATH OF FORMER MEMBER (MR JOHN KOIGIRI)** – The Speaker informed the Parliament of the death of Mr John Koigiri on 9 November 2014, a former Member for the Obura-Wonenara Open Electorate in the 7th National Parliament from 2002 to 2007. He was appointed a Member of the Constitutional Laws and Acts and Subordinate Legislations Committee and Culture and Tourism Committee between 2002 and 2007.

As a mark of respect to the memory of the deceased, all Members present stood in silence.

PRESENTATION OF PETITION: Mr Sam Basil (Deputy Leader of Opposition and Member for Bulolo) presented a petition from certain citizens of various provinces residing at ATS Settlement, east of Jacksons Airport, National Capital District praying that the Government intervene and identify the status of the concerned piece of land, and upon confirmation, give priority to the current settlers titles for permanent settlement.

Petition received.

Matter Referred to the Parliamentary Referral Committee on Land and Environment: Mr James Marape (Leader of Government Business), moved – That in accordance with Standing Order 128 (c), the petition be referred to the Parliamentary Referral Committee on Lands and Environment.

Question - put and passed.
