Thursday, 15 May 2014

- 1 The Parliament met at ten o'clock a.m. pursuant to adjournment. The Speaker (Mr Theo Zurenuoc) took the Chair.

*Absence of quorum:* The Speaker reported to the Parliament that a quorum of Members was not present and announced that he would again take the Chair at the ringing of the Bells.

*Suspension of sitting:* At ten o'clock a.m., the Speaker left the Chair.

*Resumption of sitting:* At twenty minutes to eleven o'clock a.m., the Speaker resumed the Chair, and a quorum of Members being present and in accordance with Standing Order 34, invited Mr Tobias Kulang (Member for Kundiawa-Gembogl) to say Prayers.

- 2 **QUESTIONS:** Questions without notice were asked.

- 3 **SUSPENSION OF STANDING ORDERS – RE-ARRANGEMENT OF BUSINESS:** Mr Charles Abel (Acting Leader of Government Business), by leave, moved – That so much of the standing orders be suspended as would prevent notice Nos. 136, 139 and 140 Government business, being called on forthwith.

Question – put and passed.

4 **HIGHER EDUCATION (GENERAL PROVISIONS) BILL 2014:** Ms Delilah Gore (Minister for Higher Education, Research, Science and Technology), pursuant to notice, presented a Bill for an Act to:-

- (a) establish the Department of Higher Education, Research, Science and Technology to foster –
- (i) the national development of higher and technical education with regard to the needs and resources of Papua New Guinea; and
  - (ii) the rationalization and coordination of higher and technical education so that the most effective use can be made of the resources available for higher and technical education; and
  - (iii) the maintenance and enhancement of standards and quality in higher and technical education; and
  - (iv) the coordination, planning, management and monitoring of research; and
  - (v) the promotion of innovative technologies for the development of the country; and
- (b) establish the National Higher and Technical Education Board as the national quality assurance and regulatory body for higher and technical education in Papua New Guinea;
- (c) repeal the Higher Education Act 1983 and other laws;
- and for related purposes.

Bill read a first time.

Leave granted for the second reading to be moved forthwith.

Ms Delilah Gore moved – That the Bill be now read a second time.

Debate ensued.

Mr Patrick Pruaitch moved – That the question be now put – put.

And the question – That the Bill be now read a second time – was put accordingly and passed – Bill read a second time.

*Message from the Governor-General – Recommendation for the expenditure of public monies:* The Speaker announced that he had received a message from His Excellency, the Governor-General, dated 8 May 2014, recommending the expenditure of public monies of Papua New Guinea in accordance with Section 210 of the *Constitution* insofar as the Bill relates to and provides for such expenditure.

Leave granted for the third reading to be moved forthwith.

Ordered – That the Bells be rung.

And the question – That the Bill be now read a third time – put

Bill read a first time.

Leave granted for the second reading to be moved forthwith.

Mr Charles Abel moved – That the Bill be now read a second time.

Debate ensued.

Question – put and passed – Bill read a second time

Leave granted for the third reading to be moved forthwith.

On the motion of Mr Charles Abel, the Bill was read a third time.

- 7 **ADJOURNMENT:** Mr Charles Abel (Deputy Leader of Government Business) moved –  
That the Parliament do now adjourn.  
Question – put and passed.
